Your personal information will not be shared or provided to any other third party.

# The Councils Right to Process Information

#### Information Security

Metheringham Parish Council has a duty to ensure the security of personal data. Upon completion of the above you should confirm in writing or by email to the Parish Clerk that no copies of any communication or document pertaining to council business are retained by you in any form.
